Physician Certification of Terminal Illness • A written certification must be obtained no later than 2 calendar days after hospice care is initiated (that is, by the end of the third day) • If the hospice cannot obtain a written certification within 2 calendar days, it must obtain an oral certification within 2 calendar days 12

Determining Terminal Status •Documentation certifying terminal status must contain enough information to support terminal status upon review. •Re-certifications require same Clinical Standards are met as certification. •Documentation must paint a picture of why the patient is appropriate for Hospice and the Level of Care provided.

An addendum needs to be added to the election process, titled "Patient Notification of Hospice Non-Covered Items, Services and Drugs." This addendum must include: Name of the hospice; Beneficiary's name and hospice medical record identifier; Identification of the beneficiary's terminal illness and related conditions

Documentation of Physician Certification of Terminal Illness (CTI) The Initial Certification is the first 90-day period of hospice coverage. For Medicare payment, the initial certification must contain two physician signatures if the beneficiary has designated an attending physician.

ASSESSMENT HOSPICE TOOLS

The hospice POC should link with the needs identified in the initial/comprehensive assessment. Hospices may identify needs in the comprehensive assessment that are not related to the terminal illness and related conditions. The assessment should document that the hospice is aware of these needs and . if warranted, note who is addressing them.

Creating An Effective Hospice Plan of Care

• Medicare requires that the hospice complete a comprehensive hospice assessment that identifies the patient's physical, psychosocial, emotional, and spiritual needs related to the terminal illness and related conditions, and address those needs in order to promote the hospice patient's well-being, comfort, and dignity throughout the dying process.

The hospice Plan of Care (POC) maps out needs and services supplied for a Medicare patient facing a terminal illness, as well as the patient's family/caregiver. The Centers for Medicare & Medicaid Services (CMS) data indicates that some hospice POCs are incomplete or incorrectly enacted.

Creating An Effective Hospice Plan of Care (Print-Friendly)

This initial assessment must identify the psychosocial, emotional, and spiritual needs related to the terminal illness that must be addressed in order to promote the hospice patient's well-being, comfort, and dignity throughout the dying process. As you may already know, I like the DAROP format.

Initial Chaplain Visit Assessment and Documentation ...

Documentation to support whether the beneficiary's chosen attending physician is a member of the hospice physician group, as applicable. Certification (s) of Terminal Illness (CTI) that cover the DOS under review. Face-to-Face Encounter Attestation statements as applicable to the certification period (s) during which the CHO care was provided.
